  - An experience in the International Trading of Fertilizer, within the immediate past one (01) year to the date of the submission of the bid.
  - Minimum annual turnover of US\$ 25 million from the International Trading Business in the immediate preceding financial year.
  - In the case of foreign bidder, a local representative/ local agent in Sri Lanka should represent on behalf of the principal.
  - The bidder shall register under the Public Contract Act No. 03 of 1987 at the Registrar of Public Contract (Registrar of Companies).
